The 2022-2023 PharmGrad Applicant Data Report was developed by the American Association of Colleges of Pharmacy and reflects data for 10 schools and 29 graduate pharmaceutical education (MS/PhD) programs that participated in PharmGrad during its 8th admissions cycle. "Schools" in this report refers to the colleges and schools of pharmacy that participated in PharmGrad. "Programs" refer to graduate pharmaceutical degree and certificate programs that utilized PharmGrad. Participation changes during the 2023-2024 cycle are not reflected below, nor included in this report. OVERALL APPLICANT AND APPLICATION TRENDS

The 2022-2023 PharmGrad Applicant Data Report reflects 510 applicants with Submitted application status who applied via the Pharmacy Graduate Application Service (PharmGrad) during the 2022-2023 (8th) admissions cycle. Applicants with Submitted status sent a total of 623 applications to 10 colleges and schools of pharmacy and 29 programs that participated in PharmGrad.


The PharmGrad Applicant Data Report differs from the annual PharmCAS Applicant Data Report in several ways. Firstly, the PharmGrad report refers to applicants with Submitted status (Verified and Complete only), while the PharmCAS report refers to applicants with Verified status. The PharmGrad Applicant Data Report also provides fewer tables because the application fields and processing differ in the following ways:

- No acceptance data is captured from PharmGrad programs.
- No disadvantaged fields are captured on the PharmGrad application.
- Full transcript verification is not available in PharmGrad.
- The PCAT is not required or accepted by PharmGrad programs.

Data in this report may differ from WebAdMIT and other AACP reports due to differences in how the data were collected, organized, and verified.

Figure 1: PharmGrad Participation, Applicant, and Application Trends (2016-2023)








Figure 3: PharmGrad Applications per Applicant Ratio (2016-2023)





Figure 4: Total Number of PharmGrad Applications (2016-2023)




Figure 8: Percentage of PharmGrad Applicants by Age and Sex





Figure 9: Percentage of PharmGrad Applicants by Sex

GENDER IDENTITY

In addition to sex, PharmGrad began to capture gender identity for the first time in the 2021-2022 admission cycle. The optional item on the PharmGrad application states, "We understand that your sex may not necessarily be binary. How do you describe your current gender identity? Select all that apply." The response options are: Female/Woman, Male/Man, Non-Binary/Third gender, Trans female/Trans woman, Trans male/Trans man, or Prefer to self-describe.





Figure 14: PharmGrad Applicants by Race/Ethnicity




Figure 17: Percentage of PharmGrad Applicants by Race/Ethnicity per Cycle (2017-2023)




Figure 20: Percentage of PharmGrad Applicants by Citizenship Status
