In November 2016, the AACP Board of Directors endorsed the Cooperative Admissions Guidelines (CAG), a set of admission traffic rules for pharmacy schools and applicants. Below are selected excerpts.

On or Before March 1:

Applicants may choose to accept multiple admission offers.

Schools and colleges may require a maximum \$200 holding deposit.

After March 1:

Applicants may hold only one acceptance.

Schools and colleges may require a second deposit, and will set the dollar value, if applicable.

The CAG is not applicable to early decision applicants. While all PharmCAS and non-PharmCAS schools/colleges are encouraged to abide by the CAG by the 2019-2020 cycle, AACP does not enforce them. This section of the survey is intended to assist the Board in its on-going evaluation of the CAG. As with the rest of the survey, only aggregated, de-identified results will be reported.
