






Number of Schools Participating in PharmCAS by Cycle






PharmCAS Verified Applicants by Cycle


PharmCAS Verified <u>Applications</u> by Cycle


PharmCAS Applications to Applicant Ratio by Cycle


Mean Number of PharmCAS Verified Applicants by School Type and District




Percent Change in PharmCAS Verified Volume by Cycle









Applications to undergraduate institutions have declined for 6 years in a row.

Possible Reasons for Decline

General

- Fewer students in the pipeline
- Greater interest in other STEM fields (e.g., IT)
- Greater concern about educational indebtedness

Admissions

- Greater participation in Early Decision
- Less incentive for applicants to apply to multiple schools, if they are accepted earlier in cycle
- 3X platform inflates in-progress numbers

Pharmacy-specific

- Slower job growth in pharmacy
- Negative views by some current pharmacists
- Misperceptions about pharmacy careers



What PharmCAS changes were made mid-cycle to address the 2017-2018 decline?

- Added 3 later deadline options for schools
- Enhanced applicant nurturing emails (EMP)
- Refreshed PharmCAS social media presence
- Added state and feeder institution data to AACP monthly update to assist schools in recruitment
- Presented "Creating a Great Personal Statement" webinar for applicants.
- Pursued AACP Priority #1 initiatives



What impact did changes have on PharmCAS volume?

In December 2018 PharmCAS applicant volume was down by nearly 9% and application volume was down by 30% as compared to the same point in time during the previous cycle. While still in decline, PharmCAS volume did gain some ground by July 1 with verified applicants down by 1.8% and applications down by 20%. Final data will be available in the fall.





What impact did the 3 new deadline options have on PharmCAS volume?






Did the new "Program Materials" section in 3X discourage applicants from applying to more schools?




Policy Review Program Plans Feature

- The Program Plans feature will be disabled at the launch of the 2018-2019 cycle until the corrected version has been made available.
- Once corrected, the Program Plans screen will only display terms relevant for pharmacy programs.



Policy Review Pre-Submission Release

Removal of the pre-submission release statement





Policy Review Application Status Categories

• In Progress:

- Applicants that have expressed an interest in your program, but have <u>not</u> submitted their application or paid application fees.
- In Progress applicants will not become your applicant until they submit their application.
- Users are able to view or search for these prospective applicants in WebAdMIT, but only contact information is visible.



Policy Review Transcript Received Date

• The transcript "Received" date in WebAdMIT reflects the date the mail was processed by PharmCAS staff and not the day the mail actually arrived in the office.



Policy Review Early Decision Button Visibility

- Last cycle there were reports of applicants being confused with the current workflow of applying to Early Decision.
- A new user experience focused around a redesigned workflow has been implemented in the application to help solve this issue.
- An outline of the improved early decision work flow can be found in <u>AACP Connect</u>.

Policy Review Professional Transcript Entry

 Professional Transcript Entry (PTE) has been turned off for the 2018-2019 application cycle.



Policy Review Extended Program Deadline Dates

- Dates for April, May, and June have been added as official program deadline selections for all PharmCAS schools.
 - November 1, 2018
 - December 3, 2018
 - January 7, 2019
 - February 1, 2019
 - March 1, 2019
 - April 1, 2019
 - May 1, 2019
 - June 3, 2019



Policy Review Spring Academic Update

- No official open date; Applicants can update their spring grades as soon as they are available.
- Spring Academic Update transcripts should be sent to <u>PharmCAS</u> rather than the schools.
- Only transcripts that are sent after the document deadline (June 28, 2019) should be sent to the schools.
- Reminder: Spring Academic Update is not verified.



Policy Review Electronic Transcripts

- PharmCAS accepts electronic transcripts from Credentials Solutions, Parchment, and National Student Clearinghouse (new for 2018-2019).
- If a feeder institution does not participate in any of these services, the applicant must arrange for an official paper transcript to be mailed from the college registrar's office.




Policy Review Deferred Applicants

- Applicants from the 2017-2018 cycle in the "Deferred" decision code can be brought forward into the 2018-2019 WebAdMIT when completing transfer settings.
- Only limited data comes over:
 - · Name, address, email, phone number, and designation.



Policy Review Fee Waiver



- Unlike in past cycles, applicants will be able to submit a PharmCAS fee waiver request at any time during the 2018-2019 cycle.
- Applicants who are approved for a PharmCAS fee waiver will have 14 days (including holidays and weekends) to use it, as compared to 45 days in past cycles.



Policy Review Criminal Background Check

- Check initiated after offer of admission by participating school
- Accepted applicants will pay a fixed \$70.00 fee to Certiphi for all searches.
- The \$70.00 fee will also apply to international applicants and domestic applicants who have lived abroad.





Policy Review Criminal Background Check

• CBC searches:

- Search by Social Security number
- Determination of areas of prior residence
- Search, based on areas of prior residence, at the local (county) level, as well as searches at the state, national, and federal levels
- Sex offender search
- Search for dishonorable discharge from the Armed Forces
- Search of the OIG Exclusions List
- SanctionsBase, a database of disciplinary actions taken by regulatory and accrediting healthcare agencies, including Boards of PharmacyWork with each school individually because the laws are different in every state





Policy Review Drug Screening

- \$53 cost to students
- 9 panel + Xtasy + oxycontin + tramadol
- Replaced Quaaludes with Xtasy
- Randomized based on school preference


